With primesign MOBILE, documents are signed with an eIDAS-compliant qualified signature – via mobile phone, conveniently, legally binding, and secure, without having to install an additional app. A qualified primesign MOBILE signature is issued online within minutes, via remote identification such as video or eID (e.g., ID Austria/Austrian mobile phone signature), and around the clock. primesign MOBILE is immediately ready for use and can be used worldwide.

primesign MOBILE can be rolled out quickly and easily within companies. Companies only need to purchase a desired number of VOUCHER codes for the issuance of a personal primesign MOBILE signature and distribute these codes internally or externally, e.g., to employees, customers, and partners. Worldwide, no minimum purchase, and no framework agreement necessary.

VERSATILE APPLICATION AND PARTNER INTEGRATION

primesign MOBILE, our qualified digital signature, works not only in conjunction with a primesign SIGNATURE SERVER or with our online signing service. Even if applications such as Adobe Acrobat Sign, Fabasoft, or other CSC-compliant signature applications are already in use, primesign MOBILE can be easily integrated and used within these applications.

ONLINE CONTRACTING

With our qualified digital signature primesign MOBILE, contracts can be legally closed online. For the conclusion of end customer contracts, such as the opening of bank accounts, mobile phone, leasing, or insurance contracts, we also offer so-called primesign MOBILE one-time signing certificates. If required, they are issued directly during a signature process and are valid for signing only once. primesign MOBILE one-time certificates enable contracts to be signed immediately and at any time without signatories having to have a digital signature in advance.

Get a personal qualified signature online & within minutes.

Due to high regulatory requirements, the issuance of qualified signing certificates (the basis for a qualified signature) used to be time-consuming and usually required personal contact. A qualified primesign MOBILE certificate, however, is issued online within minutes via remote identification (e.g. video or eID) and can be used immediately for signing. A primesign MOBILE qualified digital signature is eIDAS-compliant, achieves the highest level of legal assurance and, with a few exceptions, is legally equivalent to a handwritten signature throughout the EU.

OUR SOLUTION

primesign MOBILE is our qualified remote signing solution. For signing, primesign MOBILE offers both, classic persistent signing certificates and so-called one-time signing certificates. Persistent signing certificates are valid for up to 5 years and are well suited for use cases and users who sign on a recurring basis. One-time signing certificates are issued "on-the-fly", are only valid for one signature transaction, and are thus ideal for online contract conclusions, for example. primesign MOBILE also supports 3rd-party applications, and qualified primesign MOBILE signing certificates are trusted by default in many applications. Our own eIDAS-compliant trust center is authorized to issue qualified primesign MOBILE certificates.

FLEXIBLE REMOTE IDENTIFICATION, GET STARTED IMMEDIATELY

Based on video legitimation or an existing eID (e.g. ID Austria/Austrian mobile phone signature), identification for primesign MOBILE is quick, location independent, and user-friendly. After successful identification, the login data for primesign MOBILE must be set, and the qualified signing certificate is issued. Once issued, the signing certificate is immediately ready for use. A signature is triggered by entering the login data. Email address, password, and confirmation via mobile phone (SMS) – done.

DATA SECURITY & GDPR COMPLIANT

Documents to be signed are not transmitted to primesign MOBILE. primesign MOBILE only receives the so-called hash value (fingerprint) of a document to be signed. The content of a document cannot be derived from this. Also, our infrastructure is operated within certified data processing centers located in Austria.

FLEXIBLE BILLING

Different usage scenarios require flexible billing. primesign MOBILE offers a flat-fee model (unlimited number of signature transactions per year) or a pay-per-use option (signature transactions are billed monthly).
